The DNR conducted their 3 year Sanitary Survey Inspection. The WDNR determined the Nekoosa Water System has adequate technical, managerial and financial capacity to provide safe drinking water. Nekoosa's ability to plan for, achieve and maintain compliance with the drinking water standards has been demonstrated. We are also continuing to improve operational and maintenance procedures and are applying preventative measures for our aging infrastructure. The Nekoosa Waterworks performed Lead and Copper testing in 2017. Houses must meet a certain criteria set by the DNR to be considered a testing site. All lead and copper results came back below the MCL (maximum daily allowance) allowed by the DNR.

Opportunity for input on decisions affecting your water quality

The Common Council Meeting is held on the second Tuesday of each month at 7:00P.M. During the meeting there is a 10 minute citizen's forum where citizens can discuss issues.

Health Information

Drinking water, including bottled water, may reasonably be expected to contain at least small amounts of some contaminants. Educational Information

The sources of drinking water both tap water and bottled water; include rivers, lakes, streams, ponds, reservoirs, springs and wells. As water travels over the surface of the land or through the ground, it dissolves naturally occurring minerals and, in some cases, radioactive material, and can pick up substances resulting from the presence of animals or from human activity.

Contaminants that may be present in source water include:

- Microbial contaminants, such as viruses and bacteria, which may come from sewage treatment plants, septic systems, agricultural livestock operations and wildlife.
- Inorganic contaminants such as salts and metals, which can be naturally- occurring or result from urban storm water runoff, industrial or domestic wastewater discharges, oil and gas production, mining or farming.
- Pesticides and herbicides, which may come from a variety of sources such as agriculture, urban storm water runoff and residential uses.
- Organic chemical contaminants, including synthetic and volatile organic chemicals, which are by-products of industrial processes and petroleum production, and can also come from gas stations, urban storm water runoff and septic systems.
- Radioactive contaminants, which can be naturally occurring or be the result of oil and gas production and mining activities.

In order to ensure that tap water is safe to drink, EPA prescribes regulations that limit the amount of certain contaminants in water provided by public water systems. FDA regulations establish limits for contaminants in bottled water, which shall provide the same protection for public health.

Level 2 Assessment	A Level 2 assessment is a very detailed study of the water system to identify potential problems and determine, if possible, why an E. coli MCL violation has occurred or why total coliform bacteria have been found in our water system, or both, on multiple occasions.
MCL	Maximum Contaminant Level: The highest level of a contaminant that is allowed in drinking water. MCLs are set as close to the MCLGs as feasible using the best available treatment technology.
MCLG	Maximum Contaminant Level Goal: The level of a contaminant in drinking water below which there is no known or expected risk to health. MCLGs allow for a margin of safety.
MFL	million fibers per liter
MRDL	Maximum residual disinfectant level: The highest level of a disinfectant allowed in drinking water. There is convincing evidence that addition of a disinfectant is necessary for control of microbial contaminants.
