

# **POLICE CHIEF'S REPORT**





# **Property & Evidence**


Property and Evidence is a vital segment of the operations of the Nekoosa Police Department. Officer Chris Meyer, the department evidence technician stays current and accurate with the collection, processing and storage of all items taken into evidence.

2018, **598** items were In collected and processed into evidence our storage facilities. Most items are stored in our secure police department facility and large items such as bicycles, vehicles and furniture are stored off-site. Currently there are <u>926</u> pieces of property

stored by the Nekoosa Police Department.

In an effort to combat prescription drug abuse, the department continues to provide the drug-drop box in the City Office lobby. We also participate in biannual DEA sponsored prescription drug "take back" events. In 2018, over 120 pounds of unused prescription drugs and medications were collected by the Nekoosa Police Department through the drop box and events to reduce abuse and harmful environmental impact on our groundwater.



# Training

Training is one of the most important components of law enforcement operations. The Wisconsin Law Enforcement Training and Standards Board mandate that officers receive a minimum of 24 hours of training each year to remain a certified law enforcement officer. Staying current with trends, law and tactics greatly lessens the risk of liability and keeps officers and those they come in contact with safer.

In an effort to enhance our training experience, officers of the department have been trained to be instructors in the major mandatory areas of recertification training. Assistant Chief Kolo is the Training Coordinator, Defensive Tactics, Tactical Response, A.L.I.C.E. and Taser Instructor, Officer Machon is Emergency Vehicle Operations and Vehicle



Contacts Instructor and Chief Woods a Firearms and Academy Scenario Instructor. We believe that having inhouse instructors and training will increase the frequency of training and save the city money for tuition and travel expenses.


Tactical skills such as firearms cover ongoing training with handgun, shotgun and patrol rifle. This training is generally done at the Nekoosa PD shooting range. Emergency Vehicle <u>Operations</u> and Vehicle Contacts

covers driving skill and tactics. Defensive Tactics teaches officer safety and arrest tactics. As part of all these tactical skills, use of force law and procedure is always a part of the training. Additionally, all officers are trained in Crisis Intervention to aid in the response to mental health calls for service.




### **Patrol Services**

The Nekoosa Police Department patrols the City 24 hours each day, seven days a week. This past year, officers responded to 3,552 calls for service. Attentive and dedicated patrol led to 533 traffic citations. Officers also issued 126 nontraffic municipal citations and made <u>316</u> criminal arrests.



#### **MOST FREQUENT CALLS FOR SERVICE**










#### **CRIMINAL ARRESTS - 5 YEAR TOTALS**




#### **DRUG ARRESTS - 5 YEAR TOTALS**




**2018 DRUG OFFENSES**

# **K9 Program**

The reality of a K9 Program came true in 2018. It seemed like an enormous challenge with no budgeted money to start the program or sustain it. If this program was to exist, it would be entirely from community support. With no dog, kennel, vehicle, training or equipment, \$92,000 became the target goal to jump start the program. We have been extremely humbled as the greater Nekoosa community showed their support. We not only reached our goal, but surpassed it by almost \$10,000 in just four months! It is clearly evident that the value of this important tool is also realized by our supporters.






#### **K9 PROGRAM START UP BUDGET**

# **Code Enforcement**

The summer of 2018 was my first year working code enforcement. My first area of concentration was junk violations. Throughout the city I issued 63 junk notices. I had one non-compliance junk notice in which I issued a citation. I still am working with 4 citizens on the notices to make sure they comply by the summer of 2019.

Throughout the summer I worked with Department of Public Works with long grass notices. I issued 57 long grass notices and 5 of them required follow up from the Department of Public Works.

After working through the junk notices I started working on dilapidated building violations. I issued 28 notices for dilapidated buildings. 16 of the notices were fixed and are now in good standing. 11 of the notices I am still working with the owners in getting their properties fixed. With the dilapidated building notices I am more lenient in working with the owners depending on the amount of work that needs to be completed and the cost it would to complete the work. I did issue one citation for dilapidated building for non-compliance.

It is my plan that during the school districts spring break to contact all pending dilapidated building and junk violations to make a plan for the violations to be fixed. I also plan on putting a letter together that could go out in the water bill reminding citizens of our ordinances regarding code enforcement. I am hoping the letter will have our home owners to take initiative to clean up their properties and help beautifying the city.

I am thankful the city council allows for the code enforcement position to help clean and beautify the city.
