## **CONDITIONAL USE PERMIT APPLICATION**

Per §17.26 Nekoosa Municipal Code  
(updated 5/26/2020)

*A Conditional Use is a land use or development that would not generally be appropriate within a district but might be allowed in certain locations within the district if specific requirements are met. The compatibility must be judged on the basis of the particular circumstances and may require additional conditions set by the Planning Commission & Common Council before development or occupancy is permitted. The intent is to allow a reasonable degree of discretion in determining the suitability of a particular development at a specific location.*

*Proposed conditional use must meet the requirements of Nekoosa City Ordinance. Per Wisconsin's Open Meeting Law, comments on this permit application, either by the applicant or concerned citizen, shall be raised in person at the scheduled meeting or brought up to City Staff (through conversation, written letter or email) for review at the scheduled meeting. Due to Wisconsin's Open Meeting Law, Plan Commissioners and City Alderpersons are unable to discuss this matter outside of a scheduled public meeting.*
