

POLICE CHIEF'S REPORT

Topic #1 of the year again - COVID-19. We were hoping that 2021 was going to rebound a little faster than it did. Thankfully, the police department was able to resume normal function with little interruption from the so-called pandemic.

In an analysis of the 2021 police department budget, expenses came in 3% under budget (including certain revenues). As with most work places currently, adequate staffing has declined. In 2021, full-time wages were up more than expected due to a shortage of part-time employees. The labor pool in public service continues to see a decline which challenges department scheduling and employees. Thankfully, the officers are all dedicated and professional. They come through when needed and often put the department and their co-workers before themselves.

Equipment purchases (other than regular maintenance and supply) were very limited in 2021. The front-line vehicles in the fleet are in good shape, maintained by city mechanic Terry Fancher.


Nekoosa Police officers continue to maintain their annual certification required by the Wisconsin Department of Justice. To limit travel and training expenses, much of the required training is done "in-house." Assistant Chief Kolo is a Defensive Tactics, Taser and Tactical Response Instructor, Detective Machon is an Emergency Vehicle Operations/Vehicle Contacts Instructor and Chief Woods is a Handgun/Rifle and Scenario Instructor. In 2021, Officer Berg was also trained as a Handgun/Rifle Instructor, certified by the WI DOJ. Officer Berg will transition to the lead firearms instructor for the department. Continuing education and professional development are some of my highest priorities to promote professionalism and expertise.



PROPERTY & EVIDENCE


Property and Evidence is a vital segment of the operations of the Nekoosa Police Department. Officer Chris Meyer, the department evidence technician stays current and accurate with the collection, processing and storage of all items taken into evidence. Officer Meyer's attention to this critical function is vital to prosecution of crimes and custody of property.

In 2021, 397 items were collected and processed into our evidence storage

facilities. Most items are stored in our secure police department facility and large items such as bicycles, vehicles and furniture are stored off-site. Currently there are 731 pieces of property stored by the Nekoosa Police Department.

In an effort to combat prescription drug abuse, the department continues to provide the drug-drop box in the city office lobby. We also participate in biannual DEA sponsored prescription drug "take back" events. In 2021, over 80 pounds of unused prescription drugs and medications were collected by the Nekoosa Police Department through the drop box and events to reduce abuse and harmful environmental impact on our groundwater.



K9 PROGRAM

I am very pleased to report continued success and progress with the Nekoosa Police Department K9 program. Officer Berg and K9 Ivo are a tremendous team that not only provides a service to the City of Nekoosa, but also the surrounding area. K9 Ivo has proven to be a highly effective drug detection tool as well as wonderful public relations asset. His temperament and training are first rate and a great fit for our department. Officer Berg takes great pride in his role as K9 handler. Monthly training, annual certification, detailed reporting and an aggressive approach equal a highly effective K9 team.

K9 PROGRAM

The K9 team also assisted with searches at the Wood County Jail. Over the past year the following Illegal contraband located:

- 57.6 grams methamphetamine
- 100+ grams raw THC
- Multiple THC cartridges
- 2+ grams Cocaine
- 9.9 grams Fentanyl
- 5+ grams Heroin
- Suboxone strip
- 35+ narcotic pills
- A multitude of paraphernalia items

The annual fundraising was again a tremendous success. Our new golf scramble host was The Ridges. 132 golfers participated and there were over 40-hole sponsors. We again partnered with a great friend of the police department - Partianimal Cycle. Their summer event was a big success. Our concessions fed many bikers and attendees.

Ongoing training for a K9 team is a must. The team logged over 100+ hours,



recertified at Jessiffany Kennel in May as well as WI Law Enforcement Canine Handlers Association recertification in October.

Officer Berg and K9 Ivo also did several "meet and greets" including the Nekoosa Library and Boy Scouts.

The City of Nekoosa and surrounding area can take great pride in this highly effective resource to make the area a safer place to live.

SCHOOL RESOURCE OFFICER

Assistant Chief Kolo continues to serve the department and school district as School Resource Officer. His support to the district administrative team is quite unique. Most SRO's do not engage in day-to-day operations like Josh does. His connection with students is such a valuable asset as he fills roles as officer, teacher, counselor and friend.

The 2020-2021 School year was a very different year due to Covid 19 with social distancing, wearing masks, and students choosing to do online schooling. Unfortunately, interaction with students was not like a typical school year.

The NHS Law Enforcement Club was not able to meet due to Covid restrictions.

The end of the year showed some promise of normalcy as Humke Elementary Bike Safety and Crosswalk Safety resumed.

CODE ENFORCEMENT

Assistant Chief Kolo fills another very important role within the department as code enforcement officer. Largely during spring break and summer, there is an increased focus on city beautification. Ordinance enforcement primarily includes junk, unlicensed and/or unregistered vehicles and recreation equipment, long weeds and grass and dilapidated structures.


Assistant Chief Kolo reports the following activity:







